I. Call to Order

Chairman Quigley called the meeting to order at 6:00 p.m. Counsel Graff called the roll. Those present were Chairman Quigley, Vice Chairman Wagner, Commissioners Haynesworth, Johnson, Jermaine Johnson, Mitchell, Partridge – via Zoom and Saboo. Commissioner Lange was absent. Chair Quigley stated there will an open session for the evening only.

II. Approval of Minutes

Chairman Quigley called for a motion to approve the minutes of the March 19, 2024, annual Commission retreat held at the law office of Holland & Knight in Tysons, Virginia. Commissioner Jermaine Johnson moved to approve the minutes. Vice Chair Wagner seconded the motion. Counsel Graff called the roll. Counsel Graff called the role. The motion passed unanimously.

Counsel Graff stated that Commissioner Partridge was joining the meeting in accordance with the Virtual Attendance Policy.

Chair Quigley expressed his gratitude to the staff for planning such an informative annual strategy meeting on AI and quantum computing.

III. Expenditures Report

Chairman Quigley presented the Treasurer's Report. He stated that the report represents nine months (75%) of fiscal year 2024, 76% of the annual budget has been expended, and 72 percent of the total budget for the fiscal year.

IV. Chairman's Report

Chair Quigley shared that his wife, Ms. Rachel Stot, was just named CEO of Refraction. Ms. Stot is a co-founder of their not-for-profit organization that help develop high-growth companies in their collaborative community of entrepreneurs. He reported that ten of the eleven annual one-on-one Board of Supervisors meetings have taken place with the final one happening very soon. Next Tuesday, April at 4:30 pm, is the FCEDA's FY25 budget presentation to the Board of Supervisors. It will be available to watch to those interested.

V. President's Report

President Hoskins reported that the FCEDA international and California reps are visiting, first time in seven years, and are seeing the product up close and in person. Each of them will be presenting the next day at a "Going Global" event the next day.
